## STIPULATION

---

- According to Sec. 12(1) of the Act, “A stipulation in a contract of sale with reference to goods which are the subject there of may be a condition or a warranty”.
- Some stipulations may be essential to the contract while some may be collateral or incidental to the contract. A stipulation essential to the contract is called a ‘condition’. That which is collateral or incidental to the contract is called a ‘warranty’.
