Cost-Plus Contract

Contractors are paid for all of their construction-related expenses



Design-Build Contract

Addresses design and construction costs simultaneously



Guaranteed Maximum Price Contract

Maximum amount the owner will have to pay the contractor is capped



Incentive Construction Contract

Agreed-upon payment if the project is delivered by a certain milestone



Integrated Project Delivery Contract

A multi-party agreement between design firm, builder, and owner



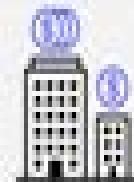
Lump-Sum Contract

Contractor delivers the project at a preset price



Time & Materials Contract

Agreed-upon price based on time spent, required materials, and profit rate



Unit Price Contract

Owner pays the contractor based on the units at agreed-upon rates
