The resource based perspective argues that while founders help in the early years of the company they become less effective as the firm evolves since they lack the necessary management skills. Design methodology approach: Using ordinary least square OLS technique this study investigates the effects of implemented factors in determining the merger premium paid in high tech acquisitions. A sample consisting of 245 acquisitions in the high tech industry of 124 CEOs during a 19 year period 1995 to 2013 has been observed. In order to test the founder CEO effects this dissertation develops a matched sample approach of 62 founder CEOs and 62 manager CEOs. This study shows a strong relationship between CEO overconfidence and acquisitions premium paid. The results suggest that the CEO overconfidence may provide an explanation for the well rehearsed overpayment problem. An additional analysis indicates that the highest premium is paid when combined acquiring and target firm CEO overconfidence exist. The dissertation also shows that founder CEOs pay higher premia than manager CEOs in the high tech industry. It has been proven that founder CEOs decisions are more independent from interventions of the board of directors and that founder CEO overpayment is not dependent on the company's size or relatedness of mergers. The findings are reliable as the results remain constant for applied robustness tests.
